<u>Fees</u>

Basis of fees

- 1. The majority of our work is undertaken on a fixed fee basis where the fee is quoted in a fixed fee agreement prior to the commencement of work on your behalf.
- 2. If our work with you is not governed by a fixed fee agreement, we will wherever possible provide you with a quote before we undertake any ad-hoc work or projects.
- 3. Whenever a quote cannot be provided, the fee will be based on the seniority and expertise of the persons carrying out the work along with the time spent on it.
- 4. If we receive your accounting records within two months of your statutory filing deadline the fee level will be commensurate with the seniority, professional expertise and time of the persons engaged in performing the work.

Payment of fees

- 1. Fees for work that is subject to a fixed fee agreement will be payable by monthly instalments through Go Cardless, or as set out in the fixed fee agreement.
- 2. All work that is not subject to a fixed fee agreement, including work quoted for, will be invoiced monthly or on completion of the project.
- 3. All invoices are due for payment 28 days from the date of the invoice. Interest will be charged on late payment at the current Bank of England base rate plus 5%.
- 4. Non payment of fees may result in work being suspended until payment is received.
